Designation of Old Town Triangle District as "Chicago Landmark".

On motion of Alderman Fifielski the City Council took up for consideration the report of the Committee on Cultural and Economic Development deferred and published in the Journal of the Proceedings of August 31, 1977, C.J.P. pp. 5761-5762, recommending that the City Council pass a proposed ordinance transmitted with the committee's report to designate the Old Town Triangle District as a "Chicago Landmark".

On motion of Alderman Fifielski said proposed ordinance was Passed, by yeas and nays as follows:

Alderman Natarus moved to Reconsider the foregoing vote. The motion was Lost.

The following is said ordinance as passed:

Whereas, Pursuant to Chapter 21, Section 21-64 of the Municipal Code of Chicago, the Commission on Chicago Historical and Architectural Landmarks has determined that the area known as the Old Town Triangle District, as described in the Appendix hereto, is worthy of designation as a "Chicago Landmark"; and

WHEREAS, On the basis of a careful consideration of the history and architecture of the district, the Commission has found that it meets the following criteria as set forth in Chapter 21, Section 21-64(b) of the Municipal Code of Chicago:

- Its character, interest, or value as part of the development, heritage or cultural characteristics of the City of Chicago, State of Illinois, or the United States.
- 3. Its identification with a person or persons who significantly contributed to the culture and development of the City of Chicago.
- Its exemplification of the cultural, economic, social or historic heritage of the City of Chicago.
- Its portrayal of the environment of a group of people in an era of history characterized by a distinctive architectural style.
- 6. Its embodiment of distinguishing characteristics of an architectural type or specimen.
- 8. Its embodiment of elements of architectural design, detail, materials or craftsmanship which represent a signficant architectural innovation.
- Its unique location or singular physical characteristic representing an established and familiar visual feature of a neighborhood, community or the City of Chicago.

WHEREAS, The Old Town Triangle District contains many fine examples of the architectural styles that were important in Chicago after the fire of 1871, most of the homes in the area having been

restored in the last 25 years, providing an excellent example of the desirability of life in the older residential neighborhoods close to the center of the city; and

Whereas, Persons important to Chicago and American history have lived in the district, such as, William B. Ogden, the first mayor of Chicago; Stephen F. Gale, the first Fire Chief; Charles J. Hull, whose home became Hull House; Eugene Field, the poet; Philip Henrici, the Restaurateur; Haddon Sundblom, who created the man on the Quaker Oats box, Aunt Jemima, and Santa Claus for the Coca Cola Company; Johnny Weissmuller; Ben Turpin; Francis X. Bushman; and Charlie Chaplin; and

Whereas, The German cultural heritage of the Old Town Triangle District bound together the original settlers and later inhabitants around St. Michael's Catholic Church and St. James German Evangelical Church; and the cultural traditions continue today in the Germania Club and the Menomonee Club; and the district today provides a home for many Chicago artists and an important art fair; and

Whereas, Many of the homes in the district are typical of the urban housing that characterized American cities in the late nineteenth century: flat- or bay-fronted, tall and narrow in proportion, and usually two or three stories tall. The architectural character of the residences in Old Town has changed little since that time, and new construction in the area has not detracted from the neighborhood. The Old Town Triangle District is an outstanding example closest to the center of the City of the original concept of a residential neighborhood in an urban society; and

Whereas, The Old Town Triangle District contains many excellent examples of the architectural styles that were popular in Chicago during the latter part of the nineteenth century, such as the Italianate and Greek Revival ornamental styles, the Queen Anne style, which is characterized by contrasting building materials, a variety of textures, and an assortment of oriel windows, dormers, terra-cotta ornament, and porches with intricately-turned supports and the Chicago Cottages, a particular building style developed during Chicago's rapid period of development before the fire of 1871 employing a method of construction known as balloon framing, which used lightweight wooden studs, joists, and rafters. Many of these houses exhibit the ornamental plaster work of John A. Boland, who was known for his outstanding work at the World's Columbian Exposition, and reminiscent of interiors in Ireland by the Italian struccadores under architect Richard Castle; and

Whereas, The Old Town Triangle District was one of the first neighborhoods in Chicago to be revitalized and restored after the Second World War, becoming one of the most valued areas in the city, and remains today an historic neighborhood with many of the traditions important to the city; and

Whereas, The Commission on Chicago Historical and Architectural Landmarks has concluded that the Old Town Triangle District is truly important to Chicago, and deserves to be preserved, protected, enhanced, rehabilitated and perpetuated; and the Commissioner of Development and Planning of the City of Chicago and the City Council Committee on Cultural and Economic Development have concurred in the Commission's recommendation that the Old Town Triangle District be designated as a Chicago Landmark; now, therefore,

Be It Ordained by the City Council of the City of Chicago:


SECTION 1. The Old Town Triangle District, as described in the Appendix hereto, which Appendix is incorporated by reference as if fully set forth herein, is hereby designated a "Chicago Landmark" in accordance with the provisions of Chapter 21, Section 21-64(f) of the Municipal Code of Chicago.

Section 2. Notwithstanding Chapter 21, Section 21-64.1(a) of the Municipal Code of Chicago no application for building permits for alteration, construction, reconstruction, demolition of or making additions to structures located within the Old Town Triangle District need be approved by the Commission on Chicago Historical and Architectural Landmarks except those permits for such work within, or which will affect the appearance of, the exterior of any such structure.

Section 3. The Commission on Chicago Historical and Architectural Landmarks is hereby directed to create a suitable plaque appropriately identifying said landmark and to affix said plaque to the property designated as a Chicago Landmark in acordance with the provisions of Section 21-64(f) of the Municipal Code of Chicago.

Section 4. The Commission on Chicago Historical and Architectural Landmarks is directed to comply with the provisions of Section 21-64(g) of the Municipal Code of Chicago.

SECTION 5. This ordinance shall take effect on and after the date of its passage.
